Registrar's Report: As of last week, there were a total of 27,800 District 5 players. For CYSA, there were a total of 217,538. On 3/15/08, there was a Registrar meeting. Fifteen (15) leagues attended. On 5/18/08 there will be a District Registration Committee meeting in Sacramento.

Association Cup: D5 U19B Laguna beat River City 4-2. There was a total of \$ 12,500 in Association Cup fines this year.

Coaching: "D" License course has changed its format. The state course will now be held over 2 consecutive weekends. For the national course, there will be an extra weekend. The cost for the state "D," for districts with a mandatory license program is \$250. It will be \$ 350 for those with a non-mandatory license program. In addition, there will no longer be a waiting period for "F" / "E" and "ED" licenses.
